As per Hon'ble Supreme Court order in IA No. 210538/2024, Dated 23.09.2024 Apex body, All India Council for Technical Education (AICTE) vide its Circular No. AICTE/RB-AC-cir/2024, Dated 24th September 2024, has published Revised Academic Calendar for Academic Year 2024-25. As per AICTE revised academic calendar the cut-off date for admission against vacancies is 23-10-2024.

This Notice is being issued for declaration of revised Cut-off Date for all types of admissions, Last date of uploading the data for institutes for admissions to Direct Second Year of Full Time Diploma in Engineering and Technology programs in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2024-25 in the Maharashtra State. This also includes Admission for Separate Division of Direct Second Year of Diploma Courses For Working Professionals.

Note:

1. Facility of Online Registration & Documents verification, confirmation of Application Form for Admission to Seats other than CAP Seats shall be continued till the Cut off date of admission.
2. The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is mandatory to get registered, documents verified and confirmation of application either by E-Scrutiny Mode or Physical Scrutiny Mode. Such candidates must apply separately to Institutes for admissions. Merit of such candidates shall be prepared by the Institute at the institute level.
3. Candidates who have opted Physical Scrutiny Mode can avail the IT facility which is available at Facilitation Centre (FC) free of cost for submission, scanning and uploading documents, and confirmation of Application form.
4. For Physical Scrutiny Mode : List of FC's is available on website and these FC's shall remain open during the schedule between 10.00 a.m. to 6.00 p.m.
5. Eligibility, Rules & regulations for admission is made available on the website.
